## **The Affordable Care Act And You** **Individual Shared Responsibility Payment**

As of January 2014 US citizens and legal residents must either:

1. Obtain Minimum Essential Health Care Coverage for themselves and their dependents - Or -
2. Have an exemption from coverage - Or -
3. Make a **payment** when filing 2014 tax return. This **payment** is called an **Individual Shared Responsibility Payment** and is either \$95 or 1% of your yearly income (whichever is higher).

The **Individual Shared Responsibility Payment** will increase substantially in subsequent years.

To avoid paying the **Individual Shared Responsibility Payment**, please contact The Legacy Group for a Coverage quote today!

### **Premium Tax Credit**

Effective January 2014, certain taxpayers will be able to use a refundable tax credit to offset the cost of health insurance premiums.

The Tax Credit is based on family size and income.
