1. **Call in.** The health insurance marketplace phone number is 1.855.461.1706. The reps can see applications you submitted on healthcare.gov and can provide direction. With internal authorization the reps can remove existing applications. We have had success and would recommend this over the website. Please always provide **Jim's NPR#** so he can provide assistance when needed (#2345855).
2. **Contact Us.** Please contact us and we can help. The Legacy Group can provide quotes and answer many questions related to Affordable Care Act (ACA) coverage.
3. **Payments are made to the insurance carrier.** You will receive statements and invoices from the insurance carrier (Medical Mutual, Anthem, etc.) and all payments will be made to your insurance carrier. Contact your insurance carrier with any payment issues or questions - not healthcare.gov.

AUTOMATICALLY INCLUDED

The Affordable Care Act (ACA) Law requires dental coverage for children as one of the 10 required "essential health benefits".

All **ON EXCHANGE ACA** policy holders no matter what their age, gender, or parental status (kids or no kids) must have all 10 essential health benefits, including Pediatric Dental coverage.

If you do not have kids or have Pediatric Dental coverage through another source and would like to opt out of this coverage you must complete and submit the **Pediatric Essential Benefits Opt-Out Form**.
