Have You Missed Healthcare.gov Open Enrollment?

Open enrollment for Healthcare.gov is closed for 2014... but there are exceptions. If you have had a **"Qualifying Life Event"** you may be able to start coverage in 2014.

What is a **"Qualifying Life Event"**? Here are examples:

1. Marriage or Divorce
2. Having a baby or adopting a child
3. Losing health coverage due to:
 - o loss of a job
 - o COBRA expiration
 - o aging off parent's plan
 - o losing eligibility for Medicaid or CHIP

Note: voluntarily ending coverage does not qualify you for Special Enrollment Period (SEP).
