How To Get Started on healthcare.gov

Are You Eligible for a Tax Subsidy?

If the **Adjusted Gross Income** for your household (single) is under **\$45,960** you **DO** qualify for a Tax Subsidy and you can access www.healthcare.gov to enroll in coverage through the Affordable Care Act. To learn more about the **AGI** requirements, please see our website at <http://www.legacyhb.com/affordable-care-act>

If you **DO NOT** qualify for a tax subsidy, please contact us - we can enroll you directly in ACA coverage.

To properly enroll when you qualify for a subsidy:

- go to www.healthcare.gov
- click "apply now for health coverage"
- choose Ohio as your state
- choose to apply online
- create an account
- apply for coverage
- start your application:
 - **When asked "Are You Working With Someone?"**
Click **YES** and enter the following information:
 - **Name: Jim Toth**

Why Is Entering Agent Information Important?

- The ACA law has gaps in coverage, not all networks and doctors are covered - we can provide this information and ensure you can keep your doctors/network
- You will have a local contact to help you with coverage questions, gather coverage information and communicate changes
- You have a personal contact who can guide you through any coverage changes you initiate (i.e. an off ACA plan, Medicare, Medicare Supplement, Small Group options etc.)

Small Group Coverage

The mandate for Small Group Coverage has been revised for ONE year

What Do I Do Now?

1. If you had a **December 1st Renewal** that will take you into 2014 - You are all set.
2. **Clients with a January renewal** – most carriers are extending to a 02.01.14 renewal.
3. **Other Carrier ACA small group rates** – call us and we can evaluate when it will make sense for you to renew in 2014 with the same carrier or another carrier.
4. **Dissolve group coverage and go with individual or family plans.** This is the most cost effective path for those not eligible for the business tax credit. We will be in touch with you during the month of December to review your individual ACA rates for 01.01.14 with the option to move then or upon your 2014 renewal.
